

PERSONAL DATA PROCESSING DURING THE REGISTRATION TO THE DATA SUMMIT LUXEMBOURG 2024

Regulation EU 2016/679 of the European Parliament and Council of 27 April 2016 (the "GDPR")

Version of 1 October 2024

1 – WHO IS PROCESSING YOUR DATA?

PNED G.I.E., branded as Luxembourg National Data Service (hereinafter LNDS), having its registered office in Esch-sur-Alzette, 6, Av. des Hauts-Fourneaux, 4362.

Whilst processing personal data, LNDS acts as data controller ("Data Controller" or "Controller"). In case of any need connected to the processing of personal data by LNDS and, in particular, in order to pursuit the relevant rights (briefly described in paragraph 7 below), the data subject can reach the Controller at its premises as indicated above, or via email at the following address: dpo@lnds.lu

2 - WHAT ARE DATA CATEGORIES, LAWFULNESS AND PURPOSES OF THE PROCESSING?

LNDS collects different categories of personal data from you via the registration form that you fill out when registering to the DATA SUMMIT LUXEMBOURG 2024. We need to collect some contact details for your registration, such as your name, email address and job information. Moreover, if you want, you can provide to LNDS additional information about your favorite topics so that we can organize an event more interesting for you.

The processing is carried out for the purpose of allowing you to register to the DATA SUMMIT LUXEMBOURG 2024 event. We will also use your data to send you essential communications about the event, organize the physical space at the venue as well as to tailor the content of the panels on the basis of your preferences.

In case you decide to register to LNDS' newsletter, LNDS will process some of the data that you provide also for sending you additional news about LNDS and its activities.

3 - HOW DO WE PROCESS YOUR DATA?

We take security measures to protect your data against the risks of destruction, loss, or alteration (accidental or unlawful), and unauthorized disclosure or access to your data.

Namely, your data will be exclusively accessed by the authorized personnel at LNDS and stored in protected files which are not possible to copy or modify by unauthorized personnel. Your personal data is stored in data centers located in the EU.

4 - TO WHOM AND WHERE ARE YOUR DATA SENT?

Your personal data will be accessible, brought to the attention of, or communicated to a few parties, either internal (e.g., LNDS internal authorized personnel) or external (e.g., suppliers or public authorities). Anyway,

only as long as this is essential to pursue the purposes indicated in this information notice.

LNDS does not transfer your personal data to third countries outside the European Union. However, it is our responsibility to mention that some LNDS' service providers might transfer your personal data to third countries. In case this happens, LNDS will implement contractual measures to ensure that the transfer of data performed by LNDS' service providers is either performed on the basis of an adequacy decision of the European Commission or on appropriate safeguards, such as EC approved standard contractual clauses.

5 - HOW LONG DO WE PROCESS YOUR DATA?

We will process your personal data to organize this event for up to 30 days after the event, after which your data will be deleted if you do not want to be kept informed about LNDS activities.

In case you provide your consent to be included in the newsletter, we will process your data for this purpose until you decide to withdraw your consent, for example un-subscribing from the newsletter.

6 - RIGHTS OF THE DATA SUBJECT

You as data subject are entitled to ask us LNDS, at any time, via the contact details indicated above, confirmation as to whether or not your personal data is being processed, as well as access to them. In case you have provided your consent to the processing of personal data, you can request to withdraw it any time.

You are entitled to the rectification or, when provided, erasure of data and the limitation of or objection to, upon legitimate reasons, the processing. You are also entitled to exercise the right to the portability of the related data which has been the object of automated processing, in case the relationship between you and LNDS is regulated by a contract or it based on your consent.

As Data Subject, you are entitled to lodge a complaint to the Supervisory Authority for the Protection of personal data: the Commission Nationale pour la Protection des Données (https://cnpd.public.lu/fr.html).

7 – COOKIES

Cookies are small text files that are placed on your equipment by our website, and which allow our website to work, work more efficiently or enable certain functionalities. The table below provides information on the cookies we use and their purpose.

LNDS does not use intrusive cookies in the sense that they are not used to collect personal data about you. We do not use targeting or advertising cookies which would allow profiling you.

For this webpage, only the following essential cookies are installed:

COOKIES	DESCRIPTION	DURATION
PHPSESSID	Cookie used to manage the user session on identials (authentication management). It contains an ID generated by the server, which links it to the SESSION of the authenticated user.	For the duration of the browsing session. The cookie is destroyed when the session is over, i.e. if the user clicks on the disconnection link, closes the browser or after the session is over. 24 hours (expiry of server-side session)
INGRESSCOOKIE	Cookie used to manage the "Sticky Session" to direct requests to the server that generated the "Sticky Session".	For the duration of the browsing session. The cookie is deleted when the user closes the browser.
